It's free and compatible with Uniswap DEX (Decentralized exchange). This is the exchange where GREENBTC (GBTC) transactions are carried out i.e. Buy, Sell, Trade, Swap.

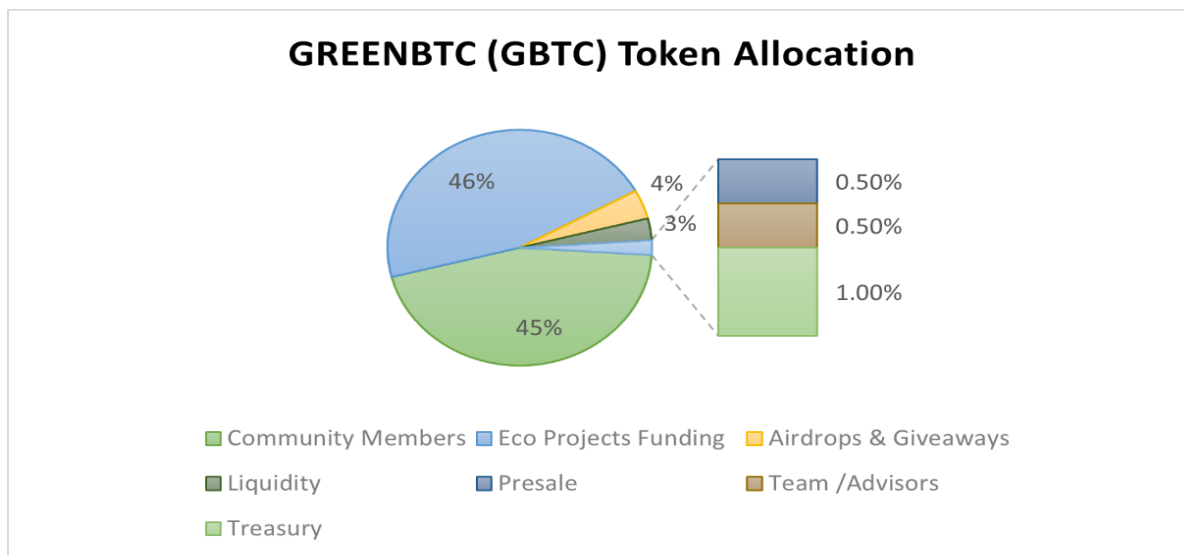
MetaMask is a browser extension and a mobile app that equips you with a key vault, secure login, token wallet, and token exchange—everything you need to manage your personal digital assets.

### Step-by-Step Guide:

1. Download the [MetaMask wallet](#).  
The MetaMask wallet can be used on PC, Tablet, & Mobile phone.
2. Create your wallet. For a guide, see this [page](#).
3. **Make sure to take a backup of your seed phrase.**
4. Buy some Ether (Ethereum) tokens using the MetaMask platform.  
ETH tokens are required to facilitate the transaction process (gas fees).  
Moonpay® is a service that is connected to the MetaMask platform which provides purchase options using a credit/debit card.
5. Now that you have your Ether tokens, go to the [Uniswap](#) exchange website.  
Here you can buy GREENBTC (GBTC) using Ether. Full details [here](#)
6. SELECT the GREENBTC (GBTC) token, or copy and paste the token contract address.

7. Type in how many tokens you want to buy, price will show along with amount of ETH paid.  
The exchange charges a **GAS fee** for every transaction (ETH is used to pay for gas fees, the *price varies throughout the day*).
8. Confirm the transaction (swap).
9. Success, transaction pending. Can be viewed on Ethereum blockchain.
